The council had a site visit a few days earlier. LPC discussed the application and **RESOLVED** (proposed KBi, 2nd MLI) to submit the following consultee comments:
*** Luxulyan Parish Council offers **NO OBJECTION** to this application on the condition that it contributes to the community with an S.106 agreement. Without an agreement of the kind to support the community, the parish council would change its consultee comments and **OBJECT** to this application on the grounds that the development is not affordable and, therefore, does not comply with the approved Luxulyan Neighbourhood Development Plan.

19/48 Assets – reports and maintenance

A Public Toilets. The parish council is very disappointed to report the vandalism of all three cubicles in the Ladies' and Gentlemen's toilets. Replacement and repair of the vandalised items has been estimated at over £100, which comes out of the parishioner's taxes. Further vandalism could raise of the parish's precept significantly or ultimately force the parish council to close the toilets. The council hopes that this will not happen again and that Luxulyan will continue to be proud of this service it offers parishioners and visitors alike. The Clerk will organise the repairs. Until then, only the disabled toilet will be available.

B Public Toilets – cleaning. A decrease in cleanliness has been reported on a few occasions by parishioners and noted by councillors. The Clerk will request that the contractor, Cormac Cleaning, conduct some spot checks to ensure that cleanliness returns to its previous standard.
